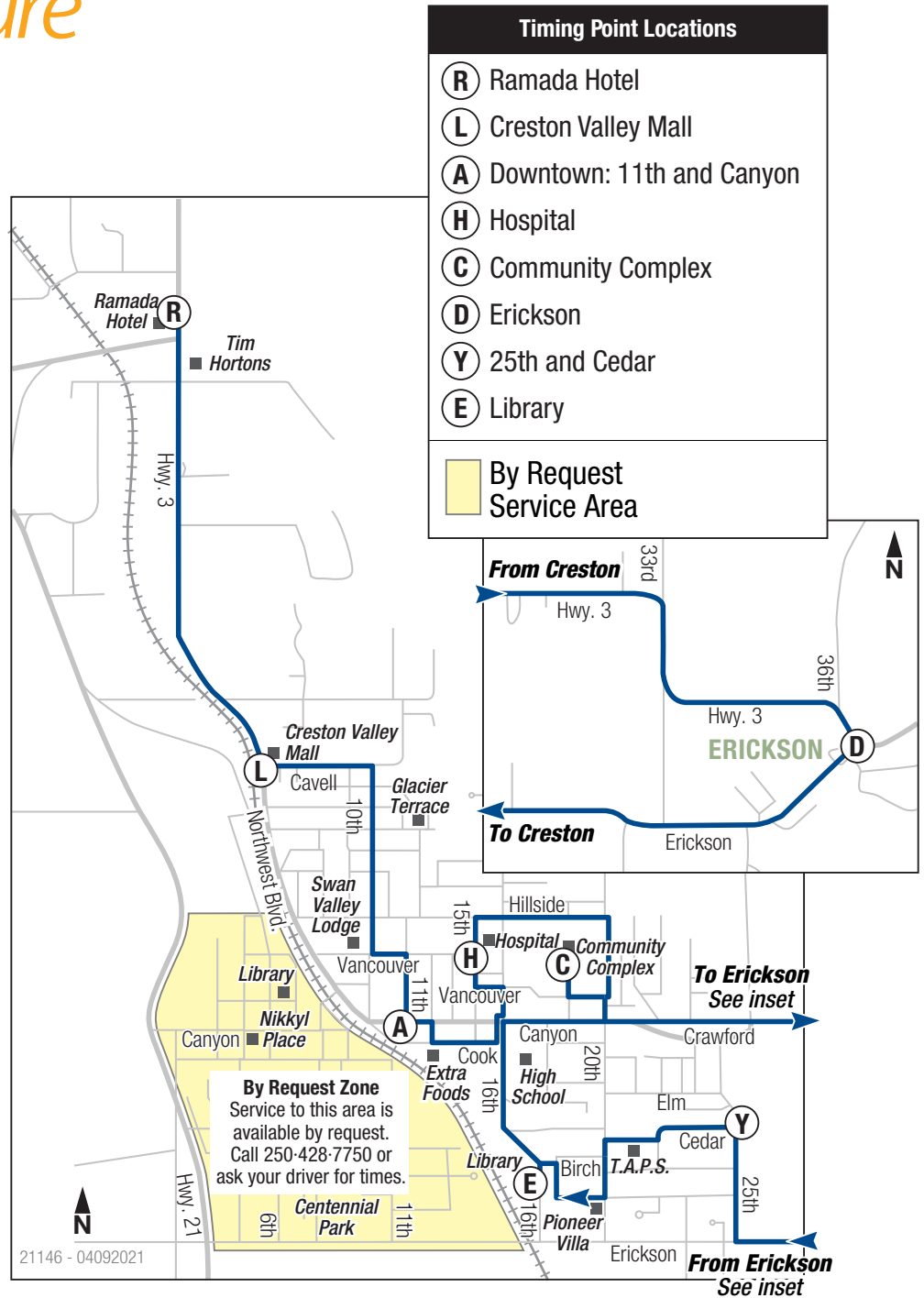


Route 1 Town Shuttle/ Erickson

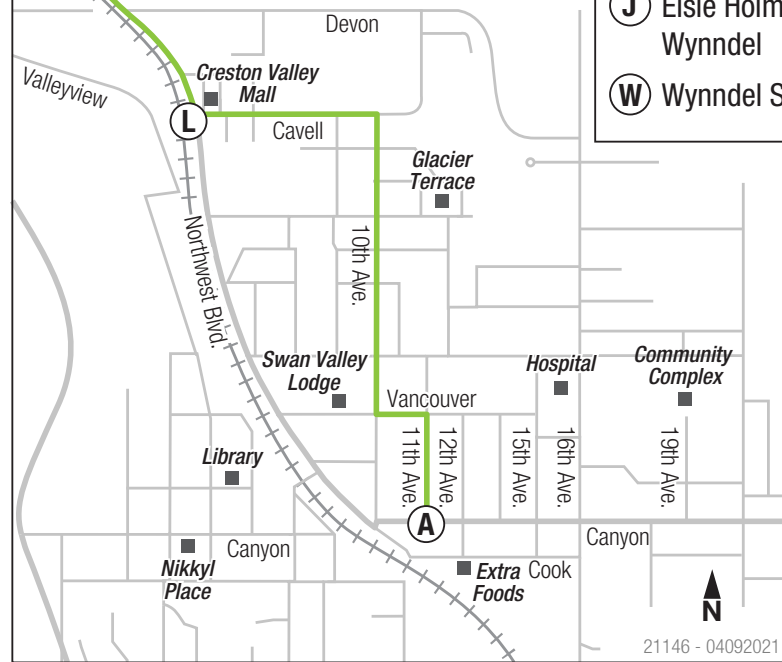

East Shore Service

Service connecting the communities along the East Shore of Kootenay Lake to Creston was identified as a priority through a Transit Future Service Plan undertaken in the West Kootenay Transit System.

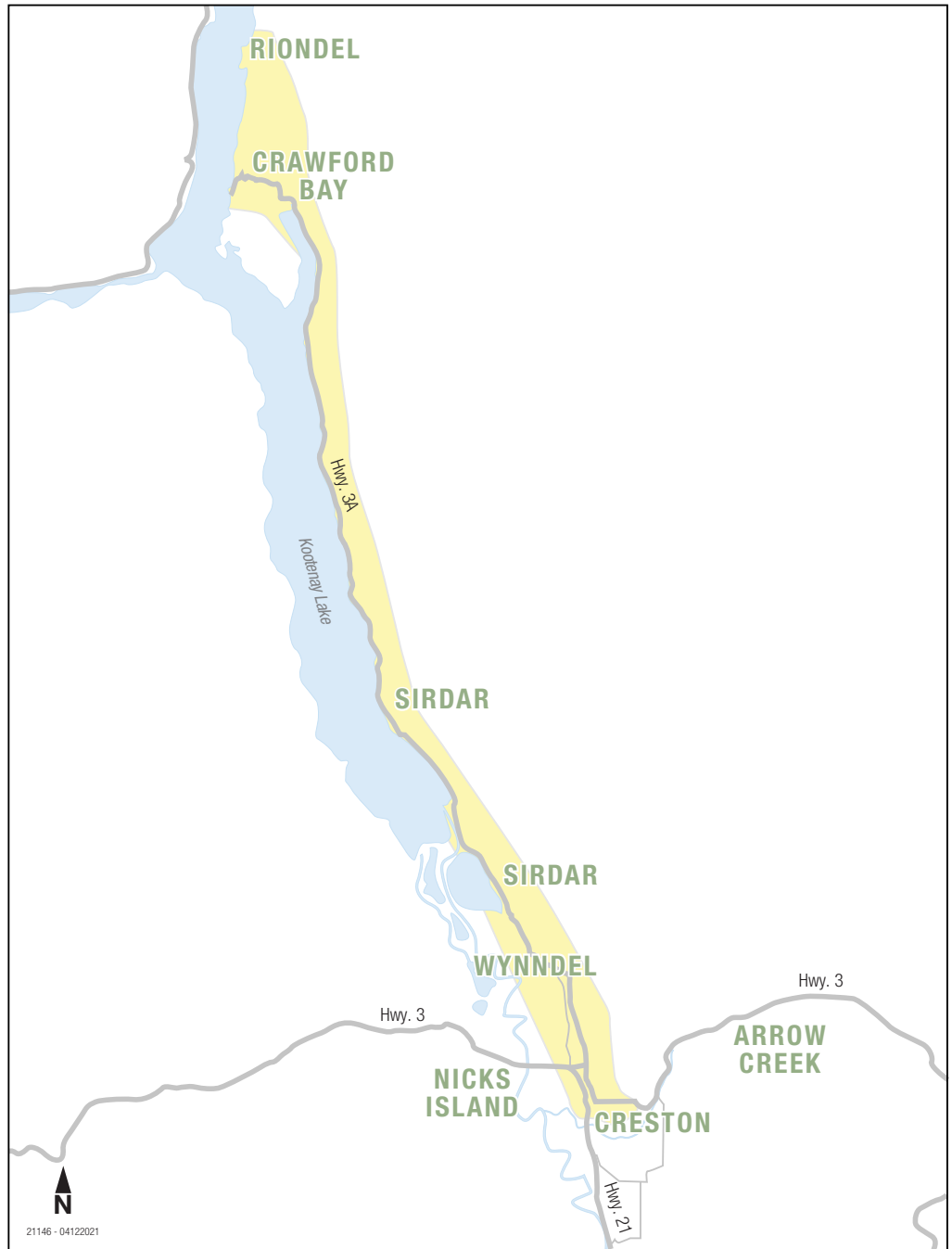
