

Voter and Service Eligibility

If you received this by mail, it likely means your household is considered eligible for curbside collection services. Go to rdck.ca/FHCurbside to confirm eligibility and register to vote in the referendum. You can also register at the polls.

Only occupied single family homes without shared waste collection are considered eligible for services. That said, anyone who lives within the service area (tenants and owners), or those who own a home here but live elsewhere in BC can vote.

Service Details

If the referendum passes, in 2025 you would receive waste collection including:

- **Bi-weekly garbage** - With a wildlife resistant garbage bin
- **Bi-weekly recycling** (printed paper and packaging) - With a new recycling container
- **Weekly food waste** - With a bear-resistant curbside bin and a counter-top container

Exact costs will only be known after next steps. **At most, households would be charged \$280.02/year, starting in 2025** with no increases until 2029. This would equal **\$23.33/month, or \$5.38/week**. The service would be a Utility Fee or a Parcel Tax, and only applied to those who have access to the service – not a general tax.

We will work to keep costs as low as possible, while still providing a good quality, reliable service.

Waste would be collected wherever your driveway meets a public road. Residents with long driveways should be able to fit the bins in their vehicles to take them to the road, or find other solutions to logistical concerns.

Troubleshooting and strategies for managing winter, steep streets, storage, wildlife and other concerns will be provided to residents if the referendum passes. We're aware of the unique challenge in our area and believe we can make this work in a safe and effective way. Rural communities similar to ours across BC receive these kinds of services successfully.

All eligible residents are encouraged to review the proposal and vote in the referendum to have your say.

- We want to know if residents support paying for the service based on the new maximum cost: \$280.02 per year (\$23.33/month, \$5.38/week)

Why Curbside? Why Now?



Improves Access

to waste disposal services and saves trips to landfills and transfer stations. Separating waste streams is easier with curbside collection.



Increases options

for diverting waste from landfills. Organic waste makes up **35%** of household waste*

Green bin pickup **accepts more** items than most at-home composters, things like:

- all fruit and veggie scraps
- cooked food
- meats + bones
- dairy + grains
- food soiled paper

*Based on provincial averages of household waste



Cost Effectiveness

Now is the best chance to receive these services at highly competitive costs – much lower than individual waste collection subscriptions.



Recycling helps reduce landfilled waste, and contributes to a circular economy. Plastic, paper and metal can all go in one collection container (co-mingled).

Why Divert Organics?



Extends Landfill Life

Cost + Space: It takes up finite landfill space, impacting capacity and lifespan of these costly sites, which also costs tax payer dollars.



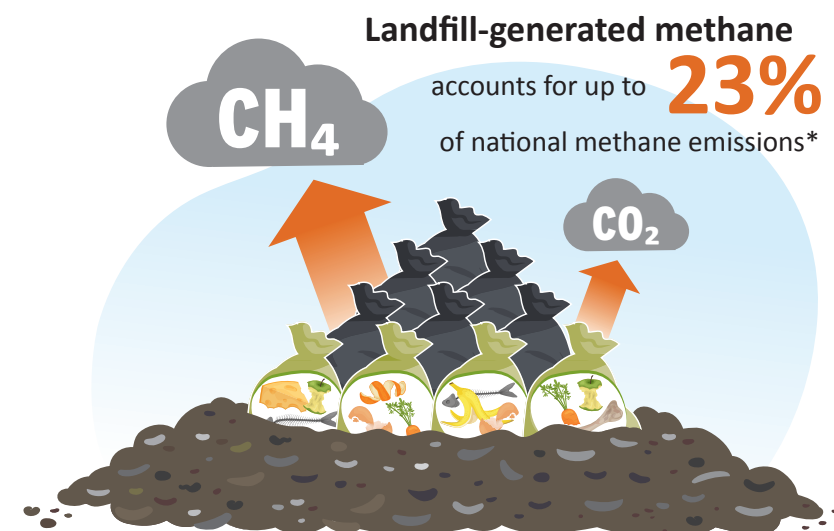
Reduces Environmental Impact

Landfills create pollution. Reducing our waste reduces the potential harm these sites have on the local environment.



Reduces Landfill Emissions

Methane Gas (CH₄): It is emitted when organic materials decompose in an oxygen-poor environment such as a landfill.



Methane emissions trap up to **80x more** heat in the atmosphere than carbon dioxide (CO₂) over 20 years*

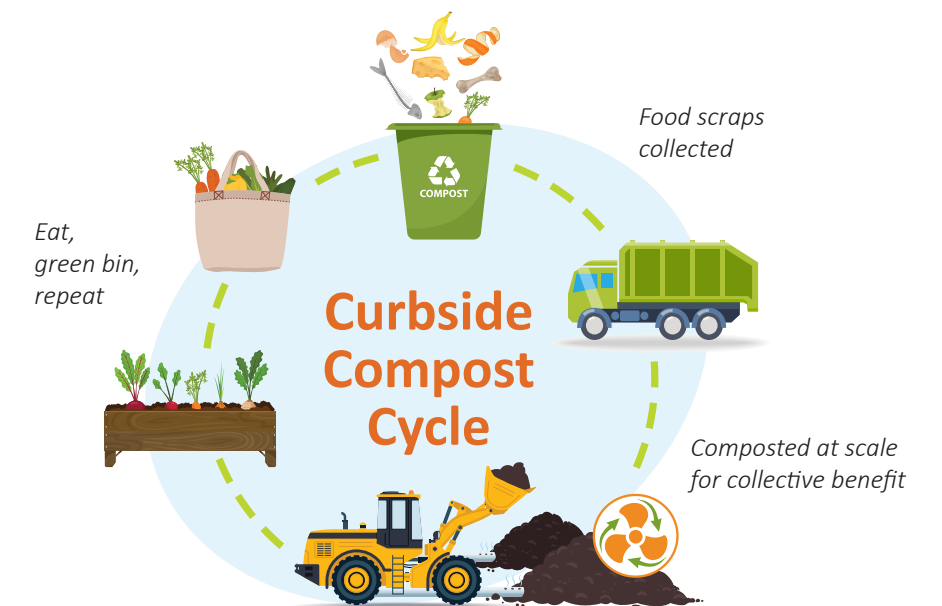
