

Aerated Compost Windrows— fans connected to aeration piping blow air into the windrows, which maintains ideal oxygen and temperature for decomposition.

Why Composting? Why Now?

In our landfills, organic waste creates significant problems:

- It takes up finite landfill space, impacting capacity and lifespan of these costly sites
- It can pollute the environment by contributing to the generation of leachate (run-off from landfills)
- When it rots in an oxygen-poor environment such as a landfill, large amounts of methane are generated. Methane is a potent greenhouse gas
 - Reducing landfill methane is a key Climate Action. Learn more at rdck.ca/climateaction

Diverting this material to composting facilities greatly reduces the negative impacts of landfilled organic wastes. Additionally, composting is a great way for us to turn waste products into a resource that is valuable to local communities for the production of healthy soils and food. You can also compost and home, if you have the space, time, know-how, and a way to keep it wildlife safe.

Organic Waste Disposal Options

The RDCK has two Composting Facilities that process organic waste in the region. The Creston and Central Composting Facilities are designed to accept most organic wastes and produce a high-quality (Class A) compost available for local uses. Compost sales are expected to start in fall 2024. Stay Tuned!

When open, customers can dispose of organic waste at four RDCK Waste Disposal Facilities.

Organic Waste Tipping Fees - 2024

The Organic Waste tipping fee is lower than Mixed Waste. Customers can dispose of organic waste by weight or by container.

By Weight: \$96.75/tonne (min. charge of \$9.75)

By Container: \$2.50 (4 x 120L max)

If Organics are brought in with garbage, <u>one</u> organics container can be disposed of for FREE

Accepted Materials

The Composting Facilities are able to accept:

- All fruits and vegetables
- Raw, cooked, and spoiled foods
- Un-waxed, non-glossy food-soiled paper/cardboard
- Dairy, eggs, fish, and meat scraps
- Breads, grains, nuts, and seeds
- Household plant cuttings, leaves, and flowers
- Wooden utensils, chopsticks and toothpicks
- Non-liquid cooking oils, fats and grease
- Grass clippings, dead leaves, straw, and twigs
- Livestock manure
- Animal bedding from wood, straw, or sawdust
- Non-liquid brewery and winery waste
- Dehydrated food waste*
 - *Commercial loads of Dehydrated Food Waste subject to additional charge

Not Accepted Materials

While our facilities accept things not typically composted at home (meats, bones, cooked food etc.) there are many items that must stay out of the composting facilities.

The Composting Facilities will not accept:

- Household garbage
- Liquid oils, fats and grease
- Glass, metal, or sharp items
- Loads more than 5% "free liquid"
- Waxy and glossy paper and cardboards
- Cat litter or pet feces
- Noxious and invasive plants
- Animal bones more than 5cm in diameter
- Whole animal carcasses, entrails, and offal
- Ash and soot
- Plastics of any kind, including those labelled as "compostable/biodegradable"

Compostable or biodegradable plastics are not designed to break down in smaller, low-tech facilities like the RDCK's. This means they likely won't fully decompose quickly enough and can create plastic litter. 100% plant fiber products for bin liners etc. are best.

Dumped loads containing prohibited material will be charged double the mixed waste rate.

Larger loads that could fill a pick-up truck bed require 48-hours notice for disposal.
