The Regional District of Central Kootenay (RDCK) is inviting applications for the part-time position of LS1 at the Creston & District Community Complex.

The LS1 provides operational supervision of the aquatic area (pools, deck, change rooms, steam room, viewing area, etc.) and monitors pool use to ensure that the daily operation is following department policies and safety standards. In addition, this position provides mentorship to staff, lifeguards and instructs, performs a variety of custodial and facility maintenance tasks and assists with the operation and delivery of aquatic programs, recreation programs and special events. This role requires the individual to demonstrate strong leadership abilities and possess a functional knowledge of pool chemistry and operating procedures.

REQUIRED KNOWLEDGE, SKILLS AND ABILITIES:

- Knowledge of the methods, tools and equipment used in lifeguarding
- Knowledge of the lifeguarding rules, regulations and practices
- Knowledge of WHIMIS procedures
- Knowledge and ability to perform first aid, CPR and instruction in the pool
- Knowledge of emergency procedures
- Ability to deal courteously and effectively with the public
- Ability to work with minimal supervision, exercise considerable independence of judgement/action in the operation of the aquatic centre
- Demonstrated teamwork and leadership abilities with an ability to effectively communicate with supervisors, co-workers, and members of the public
- Commitment to the RDCK values: Health and Safety, Integrity, Accountability and Respect.
