**PRESENT USE AND PURPOSE OF PERMIT REQUESTED:**

The property is currently being used as a design and manufacturing facility for wood and steel based home construction projects. The two buildings on site contain the site office and manufacturing facility. Remaining area on site is used for storage, construction, and parking. The applicant is proposing to expand the existing facility by building Phase 1 in the short term and proposing further expansion of Phase 2 and 3 (see attached documents for proposed site plans) in the coming years. The proposal triggers a Development Permit as the property is designated as Industrial (M) under the *Electoral Area 'F' Official Community Plan Bylaw No. 2214, 2011*. The intent of the industrial DP is to guide form and character of new developments, ensure that new development contributes to creating a high quality public realm and that it fits within the rural context of the region, and conserve water and energy through the promotion of renewable energy sources. A Development Variance Permit has been submitted to reduce the interior lot line setbacks, and is being reviewed concurrently.
