



# Evacuation Order RESCIND

**Date:** August 8, 2024

**Time:** 09:30hrs

The **Evacuation Order**, issued for the properties listed below by The Regional District of Central Kootenay is no longer required and is **RESCINDED effective as of August 8, 2024, 09:30hrs**. The **Evacuation Order RESCIND** applies to Duncan Island on the east side of Duncan Lake and boat access only parcels in Electoral Area D north of Glacier Creek Regional Park affected by the Glacier Creek (N71099) Wildfire **Evacuation Order** part of the Lavina Complex. Portions of the Duncan FSR, Glacier Creek FSR and Glacier Creek Regional Park **remain on Evacuation Order**. The **ORDER** is **RESCINDED** for the following one (1) address and fifty-one (51) parcel identifiers – PIDs (see attached map):

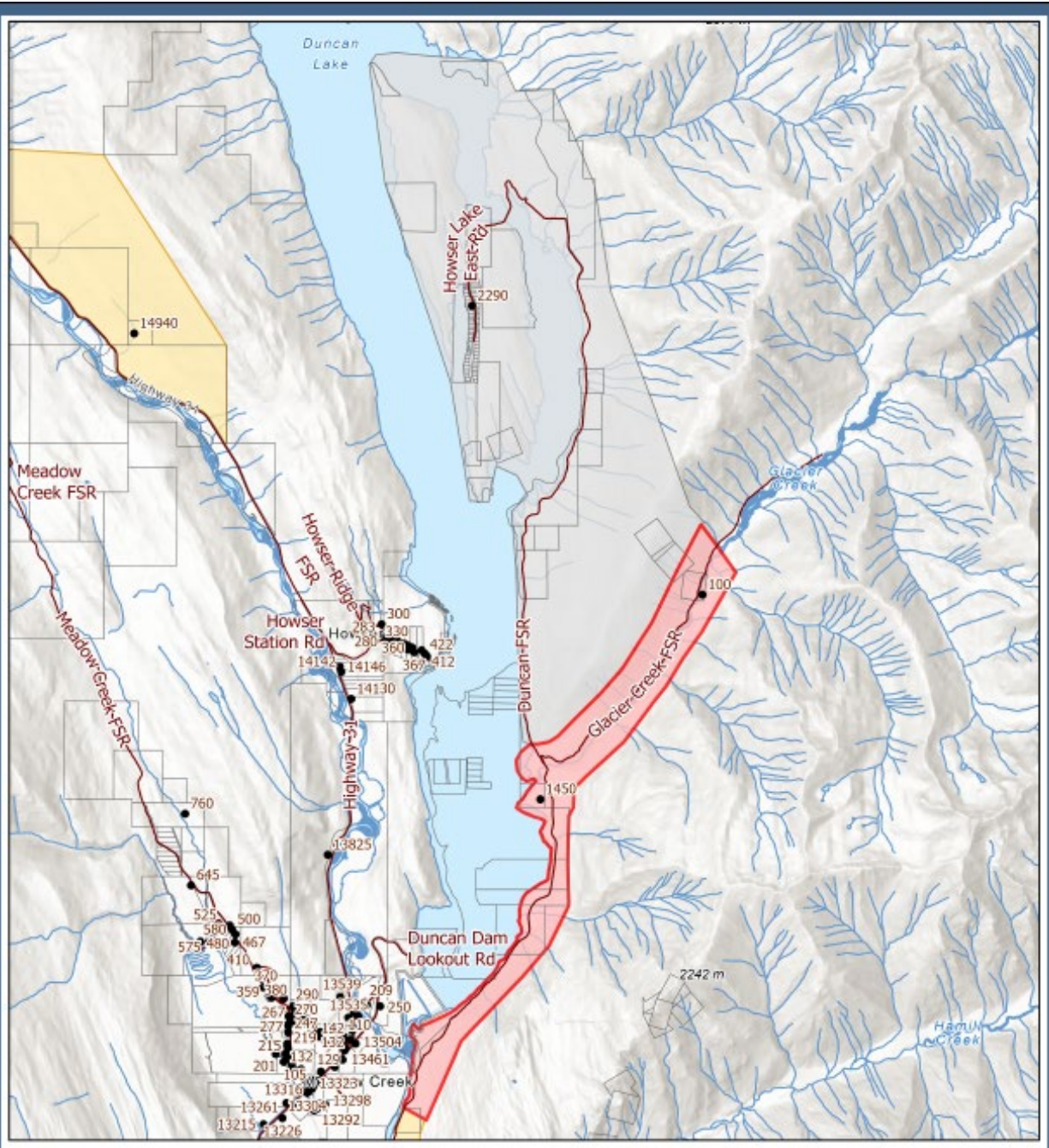
If a subsequent **Evacuation Alert** or **Order** is deemed necessary, a new Alert or Order will be made.

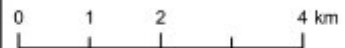
