The Village of Slocan has been advised that the potential threats to people and property in the Village of Slocan posed by the Mulvey and Ponderosa Creek Wildfires (Slocan Wildfire Complex) has diminished at this time.

The **Evacuation Alert** issued for the below area by the Regional District of Central Kootenay Emergency Operations Centre (EOC) is no longer required and is **RESCINDED** effective immediately for the entire Village of Slocan, including the following properties (see attached map):


The State of Local Emergency for Electoral Area H in the Regional District of Central Kootenay remains. There are currently 516 addresses and 195 unaddressed properties on Evacuation Alert and 1 address on Evacuation Order as a result of the Slocan Wildfire Complex.

In the event that conditions change, **Evacuation Alerts** or **Orders** may be re-issued and the evacuation process will re-commence.
