

Deceased Animal Disposal

Declaration Form & Checklist

Please Note: RDCK cannot accept "SRM" Materials at any of our sites at any time.

"Specified Risk Material" means the skull, brain, trigeminal ganglia (nerves attached to the brain, eyes, tonsils, spinal cord) and dorsal root ganglia (nerves attached to spinal cord) of cattle aged 30 months or older, and the distal ileum (portion of the small intestine) of cattle of all ages. (Health of Animals Regulation (C.R.C., c, 296).

"Agriculture Waste" means waste products from an operation regulated under the BC Waste Discharge Regulation of the *Environmental Management Act*, specifically from an agricultural operation regulated by the Code of Practice for Agricultural Environmental Management (AEM). Deceased animals originating from a residentially-zoned parcel and which were not raised primarily for the purpose of distribution to other persons are not Agriculture Waste.

"Slaughter Industry Waste" means waste products from an operation regulated under the BC Waste Discharge Regulation of the *Environmental Management Act*, specifically from a slaughter operation regulated by the Code of Practice for Slaughter & Poultry Processing Industries. Deceased animals originating from a residentially-zoned parcel and which were not raised primarily for the purpose of distribution to other persons are not Slaughter Industry Waste.

An RDCK resident, wishing to dispose of cattle that is not Agriculture Waste or Slaughter Industry Waste, must first have a qualified veterinarian contact the RDCK and also verify in writing that the animal is not SRM containing, before any cattle disposal request is considered.
