Mr. Mastel led the Board through the following documents:

- 1) The Summary of 2017/18 Global Grant items under \$100,000
- 2) The Listing of Information Management Information Technology (IMIT) Corporate Projects for 2017—2018
- 3) The MRI Exam Volume Information Report for the Kootenay Boundary Health Service Area.
- 4) The letter from Susan Brown, VP, Hospitals and Communities and Chief Operating Officer, Interior Health, regarding definitions of "emergency" and "urgent" care.

Mr. Mastel confirmed that the current Columbia View Lodge bus was funded by the KBRH Foundation.

The MRI report stated that MRI exams have increased by 24% at the Kootenay Boundary Regional Hospital. Currently, wait times for an MRI at the hospital are 16 weeks for urgent and 51 weeks for an elective exam. When the Cranbrook hospital receives its new MRI, the mobile unit will be able to serve other areas in the region, including the Kootenay Boundary. Three MRI machines are operating in the Interior Health Authority: Kelowna General Hospital, Royal Inland Hospital and the mobile unit. The province has a strategy to increase access to these exams.
